HBKU PASSES THE MILESTONE OF 1,000 GRADUATES

CIS celebrated the graduation of its Classes of 2020 and 2021, formally conferring degrees to 110 students during a virtual university-level ceremony on May 24. The milestone celebration witnessed HBKU passing the 1,000th graduate mark in the 10th year since its founding.

With CIS' expanded program portfolio, the ceremony witnessed a number of 'first cohorts,' including in the Master of Arts in Applied Islamic Ethics, Master of Arts in Islam and Global Affairs, and Master of Science in Islamic Art, Architecture and Urbanism.
